## ABC/Central Ohio MEMBER SPOTLIGHT Eric & Marla Hoeft

Eric and Marla Hoeft became members of Columbus Sail and Power Squadron, also known as America's Boating Club of Central Ohio, in April of this year. Together, they bring over 30 years of boating experience to the club. They were already familiar with the organization, having first connected with us through a long-standing business

relationship and friendship with John Seaver. It was during this association that Eric hosted an engine maintenance class for fellow boating enthusiasts at his home office and garage in Powell. Eric's passion for boating has

spanned much of his life, and fortunately for him, Marla shares that passion!

The Hoeft's boating adventure began in 1985 with the purchase of an old fixer-upper fishing boat. In 1994, they were introduced to Lake Erie boating and purchased a boat to keep in the water on Catawba Island. With the birth of their son, they switched gears and bought a 250 Sea Ray Sundancer on a trailer to use on Lake Erie and travel with their family all over the eastern United States. Destinations included: Florida, the Carolinas, Kentucky, Maryland, Michigan, etc.

In 2020, they upgraded to a Great Loop-worthy boat—a 1997 39' Mainship 350 Trawler. Purchased

in Virginia Beach, the Hoefts embarked on an epic journey in 2021, cruising 1,350 miles of the Great Loop. The trip lasted four weeks and involved five separate crews, including his wife and 10 volunteer friends and family. They started on the Chesapeake Bay, cruised up the Atlantic to New York, and the Hudson. They entered the Erie Canal in Waterford, New York, and traveled to Lake Erie and eventually Sandusky. For the next three years, the Hoefts spent time traveling on the Great Lakes and up to the Georgian Bay in Ontario.

In 2024, Eric decided to retire from the

company he had founded 27 years earlier. The retirement date was set as May of 2025, and Marla agreed that retirement would involve traveling and living on board a boat. The plan was to spend 6 months out of each year on board and 6 months at their "Dirt home." Top destinations on their list were the Bahamas and Maine. To do that, they of

course decided... they needed a bigger boat.

In October of 2024, the Hoefts visited the Annapolis Boat Show to look at Trawlers. They were able to get on board 15 different types/makes of Trawlers to refine their search requirements. With the help of a broker, they located a 2000 Ocean Alexander 510 Classico in a marina in Iuka, Mississippi. This boat was three times the size (66,000 lbs) of the Mainship and offered all the space

and amenities they felt they needed. It was manufactured in Taiwan, and the original sticker price was \$780,000. They closed on the *Ocean Alexander* (renamed *Stella Maris*) in December of 2024 and planned their next adventure, getting her to Lake Erie via the river system to Chicago.

For the trip home to Sandusky, Marla managed much of the logistics and provisioning for the trip, coordinating five crews who would each stay aboard for around eight days. Over seven weeks, Eric navigated through nine states and two countries (Canada), consuming 1,400 gallons of diesel fuel along the way. Their route took them from the Tennessee Tombigbee Waterway, through the

Tennessee, Cumberland, Ohio, Mississippi, Illinois, and Chicago rivers. Once in Chicago, Marla came on board to crew the boat for four weeks of the journey through Lake Michigan, Macki-



naw, the North Channel to Little Current, Ontario in the Georgian Bay. The 5th and final crew relieved Marla to take the boat across the Georgian Bay, down Lake Huron, through Detroit, and across Lake Erie to Sandusky, Ohio.

Looking ahead, for 2026, the Hoefts plan to travel for over six months through Montreal and to New York, arriving by October. From there, Eric will travel down the East Coast to New Bern, N.C., to wait for the Hurricane season to end by December 1st, 2026. In January 2027, they will travel to Miami and then cross over into the Bahamas. They also hope to spend time in 2027 exploring Maine.

Eric and Marla's journey has spanned decades, from navigating with paper charts and without the aid of GPS or cell phones to their current high-tech cruising lifestyle. As they reflect on their experiences, Marla emphasizes the importance of always being willing to learn and prepare for the challenges of boating. Eric agrees and is eager to share his knowledge with fellow boaters through teaching, particularly about engine maintenance, weather patterns, and navigation.

Both Eric and Marla have accumulated incredible experiences both on and off the water, and they have graciously volunteered to share their story of the Great Loop at the America's Boating Club Christmas Party at Morgan House on December 12th. Do not miss the chance to meet and learn from these seasoned boaters with such an expansive and fascinating boating history!

For anyone interested in traveling the Great Loop, Eric and Marla's 1997 Mainship 350 is currently for sale. It is listed through a brokerage called Knot10 and is located in inside heated storage in Sandusky, Ohio. She is a well-maintained and heavily upgraded trawler with proven travel abilities.

## **Important Membership Info**

USPS National changed its computer system this year to IMIS. Some information did not transfer over from the old system. To check your record for errors, complete the following steps:

- 1. Go to www.USPS.org and log in to the Membership Portal with your credentials. Usernames can be either your email address of record or your certificate number. If this is your first time logging in, click on "Forgot Password" to create your password. You can use the same password that you use on USPS. org, but your password must be seven characters and include at least one letter and one number.
- 2. Under your name in the top bar, click My Account.
  - 3. Your record will come up with several tabs.
- a) "About Me" shows you demographics, email, phone, mailing address, and who you are associated with. You can edit this information on your own.
- b) "Participation" shows which squadron you are attached to, when your dues are to be paid, and copies of invoices or receipts.
- c) "Preferences" are what publications and emails you wish to receive from National. You can change your password here and add a payment method for future dues.
- d) "Achievements" include grade, rank, merit marks received, vessel examiner numbers, total years paying dues, and certified instructor information.
- e) "Education" shows the classes and seminars you have taken, with the date.
- f) "Past Jobs" lists all positions you have held with the squadron, district, or national. If any of your information is missing or incorrect, it can be fixed by sending an email to Yvonne Hill at hilly@hq.usps. org. Please include your full name and E# with a phone number in case she needs to reach you. Include what is missing or incorrect in the email.

#### **Correct answer for Nautical Deck Query:**

1. A. "A vessel engaged in fishing underway shall, so far as possible, keep out of the way of: (i) a vessel not under command; (ii) a vessel restricted in the ability to maneuver." (d)(i) Any vessel other than a vessel not under command or a vessel restricted in the ability to maneuver shall, if the circumstances of the case admit, avoid impeding the safe passage of a vessel constrained by draft, exhibiting signals in Rule 28. Nautical Rule 28 is part of the International Regulations for the Prevention of Collision at Sea (COLREGs) and deals with vessels that are constrained by their draught.
